



MEDREG's support to energy regulatory reforms in the Southern Mediterranean: What have we achieved?

CONCEPT

In 2018, MEDREG launched a new initiative which aimed at facilitating ongoing and forthcoming energy reforms in the Southern and Eastern countries of the Mediterranean region. Based on a joint assessment of needs by MEDREG and its beneficiary members, the support provided took several forms such as exchange of information and best practices, high-level trainings for regulatory staff, study visits to peer regulators, and identification and discussion of new regulatory measures.

As this initiative has already shown some positive results, this event proposes to share some of the successes achieved in the last two years, through the voice and testimonies of MEDREG's regulatory members which benefitted from it in Algeria, Egypt, Israel, Jordan, Morocco and Palestine.

The primary audience will be the EU and national media of the Mediterranean countries, the EU decision-makers and the wider Mediterranean energy stakeholders, including the private sector.

This event will tell the stories of:

- ✓ How **Algeria** successfully launched its tender on auctioning systems to determine renewable energy prices and confidently evaluated the best price option;
- ✓ The reinforcement of the **Egyptian** energy regulator's powers on consumer protection, tariff setting and the adoption of a code of ethics;
- ✓ The opening in **Israel** of wholesale **electricity** markets, moving from monopolies to competitive markets;
- ✓ The progress achieved by the Israeli gas regulator in connecting its household consumers to gas;
- ✓ **Jordan**'s strengthened capacity to correctly give, monitor and withdraw licences;
- ✓ The establishment of **Morocco**'s new independent energy regulatory authority and how it is becoming operational; and
- ✓ Palestine's projects to establish a net metering system in the country.

Some of the Members' presentations and testimonies on the concrete achievements and improved regulatory capacity that resulted from MEDREG's support activities will be completed by a couple of case studies and success stories, that could be distributed at the event and shared digitally before and after.

MEDREG continuously assesses the progress and development of regulatory authorities in the region. Thanks to the tailor-made and detailed implementation support plans that were developed





and carried out for energy regulators of the Southern Mediterranean, MEDREG saw a reinforcement of their competences, expertise, effectiveness and role in the oversight of energy markets.
